Amendments

In the said rules,-

(1) in sub-rule (2) of rule 3, after clause(d), insert the following clause:-

" (e) has been engaged in any full time occupation:

Provided that the provision of this clause shall not be applicable to a person if he submits a declaration at the time of application that he shall regularly attend the meeting of the Commission and will discharge the responsibilities assigned to him/her for carrying out the purpose of the Act."

- (2) in rule 5, in clause (a) of sub-rule (3), omit the word "consecutive";
- (3) in rule 12, in sub-rule (1),-
 - (a) for the words and figures "Rs. 30,000/-(Rupees thirty thousand)", substitute the words and figures "Rs. 40,000/-(Rupees forty thousand)"; and
 - (b) for the words and figures "Rs. 25,000/-(Rupees twenty five thousand)", substitute the words and figures "Rs. 30,000/-(Rupees thirty thousand)".

This will take effect from 01.04.2017.

Amendments

In the said rules,-

- (1) In rule 12, in sub-rule (1), -
 - (a) for the words and figures "Rs. 40,000/- (Rupees forty thousand)", substitute the words and figures "Rs. 50,000/- (rupees fifty thousand)";
 - (b) for the words and figures "Rs. 30,000/-(Rupees thirty thousand)", substitute the words and figures "Rs. 40,000/- (rupees forty thousand)";
- (2) to rule 13, add the following provisos:-

"Provided that such leave cannot be carried forward beyond a particular calendar year:

Provided further that the conditions of service of a Government servant when appointed as Chairperson or Member of the Commission, as the case may be, shall be regulated in accordance with the rules applicable to Government servant.";

- (3) After rule 17, insert the following rule:-
 - "17A. Landline telephone and mobile allowance.—(1) The Chairperson shall be entitled to get reimbursement for expenditure incurred for landline and mobile phones at the rate of Rs. 2,000/- (Rupees two thousand) per month on submission of actual telephone bill.
 - (2) Every other Member, excepting those who are in Government Service, shall be entitled to get reimbursement for expenditure incurred for landline and mobile phones at the rate of Rs. 1,500/- (Rupees one thousand and five hundred) per month on submission of actual telephone bill".
