EMPLOYMENT NOTICE

REQUIRES LEGAL CONSULTANT

WHEREAS the West Bengal Commission for Protection of Child Rights is a product of mandate under the Commission for the Protection of Child Rights Act, 2005 and presently a statutory body constituted under the control of the Department of Women and Child Development and Social Welfare and is a specialized centre working in the area of child rights;

WHEREAS the main thrust of the Commission is to examine all factors that inhibit enjoyment of child rights, matter relating to juvenile justice, universalization of quality equitable school education, child labour and protection and justice to children through independent human rights institution and recommend appropriate remedial measures;

WHEREAS the Commission requires a Legal Consultant to work with the West Bengal Commission for Protection of Child Rights on contractual and no work no pay basis.

AND WHEREAS the Commission prescribes minimum educational qualification and experience for the post which is as follows:-

1. The candidate must be citizen of India;
2. The candidate must be Graduate of Law;
3. The candidate must have vast and sound knowledge and experience at least 5 to 8 years in the matter of law and court matters;
4. Preference will be given to those having professional experience of working in the field of RTE, POCSO, JJ Act and other child related legislation;
5. The Commission may relax the abovementioned experience for deserving candidates.
6. The salary will be negotiable;
7. He / she has to attend office regularly from 10:30 a.m. to 5:30 p.m. for all working days;
8. The initial tenure of the service contract is for a year on the performance basis;
9. The selected candidate has to enter into a contractual Service Agreement with the Commission.

AND WHEREAS the Commission will conduct interview on 20.09.2017 at 12 noon.

AND WHEREAS the Commission will work out on contract before the contractual appointment of the candidate to the post of Legal Consultant.
