West Bengal Commission for Protection of Child Rights is working persistently towards protection of the rights of children and minors in the state. Like previous years, the annual report of 2019-2020 also provides you information on the Commission's nature of work, objectives, child rights related laws, case studies and a summary of the Commission's activities and achievements in the past year. It is not only a record of few data and statistics, it is a brief history of time where you will see the challenges of protecting thousands of children. Many of them are victims of violence, abuse, neglect and discrimination every day. Such violations limit their chances of surviving, growing and blossoming of their dreams.

Any child can be vulnerable to violations in any place, including at home. The actual number of children experiencing violations is not easy to determine. While working, the Commission always keeps in mind the issues of underprivileged children. So, other than its regular job of addressing the cases received officially or taking Suo motu cognizance of the matters, the Commission organised several workshops and consultations on RTE, POCSO, Missing, Child Trafficking, Child labour, JJ Act, Child Marriage throughout the year. The Commission introduced several awards to sensitize children, police and media towards protecting child rights. Child friendly Corners in different places across the districts such as Gangasagar Mela, Poush Mela, International Kolkata Bookfair were organised where girls and boys from the remote corners of the State were encouraged to speak up for their own rights. If children are sensitized to be aware of their own rights to survive, to be safe, to belong, to be heard, to receive adequate care and protection, our job becomes slightly easier. Sensitivity and awareness are two key words which can play vital roles in preventing child rights violations and developing a better tomorrow for our children.

From the Desk of the Secretary



The West Bengal Commission for Protection of Child Rights (WBCPCR), under the Department of WCDSW, has, like in previous years, pooled comprehensive inputs to put together its Annual Report for the year 2019-20. This year's document depicts the Commission's performance and achievements in the challenging fields related to protection of child rights, ensuring child safety and implementation of the relevant Acts and Rules in this respect, like the POCSO Act, Juvenile Justice Act and

the RTE Act.

Through various kinds of plans and programmes, in collaboration with Unicef and several NGOs, WBCPCR has acted as the vigilant watchdog of the best interests of the children of West Bengal, by promoting safe and child-friendly environments. The Commission's functions, including examination and review of the safeguards provided by or under any law, for the protection of child rights and recommendation of measures for their effective and timely implementation, have been duly fulfilled during the period under report.

Always keenly concerned about the safety and security of vulnerable children, WBCPCR has swiftly acted on cases of violation of child rights, like child trafficking, child labour, child marriage and impacts of domestic violence on children, which have been duly taken cognisance of. Following required enquiries and investigations by concerned authorities, studied recommendations have been made by the Commission. Steps for initiation of proceedings in such cases have been taken up in right earnest, including factors that inhibit the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disasters, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation.

True to its child-friendly role, WBCPCR has sorted out and monitored various matters relating to children in need of special care and protection, including children in distress, marginalized arid disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners, and duly recommended appropriate remedial measures. Periodical review of existing policies, programmes and other activities on child rights have been made, along with recommendations for their effective implementation in the best interest of children. Survey and research in the field of child rights have also been duly promoted.

From the Desk of Secretary

Consultations, conferences, orientation programmes and interactive counselling sessions have been undertaken, as required, throughout 2019-20. Measures have been taken to spread child rights literacy among various sections of the society, along with promotion of awareness regarding the safeguards available for protection of these rights through publications, workshops, seminars and the like.

Deeply involved with the ideology of universalisation of elementary education, WBCPCR addressed complaints under the RTE Act with perseverance, including cases of torture of specially abled children, denial of admission in school, mental harassment and physical punishment, inappropriate teacher student ratios and non-availability of required facilities in school premises.

This Annual Report highlights the outcome of workshops conducted by the Commission throughout West Bengal. Hearings have been held, as required, and training programmes organised. Observances of the State Child Protection Day, the Child Rights' Week and the International Child Rights Day were successfully undertaken.

I am thankful for the initiatives taken by the multi-level workers linked with WBCPCR and truly appreciate the valuable inputs provided for this publication, by the various sections as well as units under the aegis of the Commission and the Department of WCDSW, and look forward to enriching feedback, and interaction, in this context, from all quarters.

Chapter 3: Functions and Powers of WBCPCR

- 13. (1) The Commission shall perform all or any of the following functions, namely:
 - (a) examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation;
 - b) Present to the Central Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards;
 - (c) inquire into violation of child rights and recommend initiation of proceedings in such causes;
 - (d) examine all factors that inhibit the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disaster, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures;
 - (e) look into the matters relating to children in need of special care and protection including children in distress, marginalized arid disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures;
 - (f) study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendation for their effective implementation in the best interest of children;
 - (g) undertake and promote research in the field of child rights;
 - (h) spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means;
 - (i) inspect or cause to be inspected any juvenile custodial home, or any other place of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organisation; where children are detained or lodged

for the purpose of treatment, reformation or protection and take up with these authorities for remedial action, if found necessary;

- (j) inquire into complaints and take suo motu notice of matters relating to,-
- i) deprivation and violation of child rights;
- ii) non-implementation of laws providing for protection and development of children;
- iii) non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities; and
- (k) such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.
- (2) The Commission shall not inquire into any matter which is pending before a State Commission or any other Commission duly constituted under any law for the time being in force.
- 14. (1) The Commission shall, while inquiring into any matter referred to in clause (j) of sub-section (1) of section 13 have all the powers of a civil court trying a suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters, namely:—
 - (a) summoning and enforcing the attendance of any person and examining him on oath;
 - (b) discovery and production of any document;
 - (c) receiving evidence on affidavits;
 - (d) requisitioning any public record or copy thereof from any court or office; and
 - (e) issuing commissions for the examination of witnesses or documents.
 - (2) The Commission shall have the power to forward any case to a Magistrate having jurisdiction to try the same and the Magistrate to whom any such case is forwarded shall proceed to hear the complaint against the accused as if the case has been forwarded to him under section 346 of the Code of Criminal Procedure, 1973.
- 15. The Commission may take any of the following steps upon the completion of an inquiry held under this Act, namely;
 - (i) where the inquiry discloses, the commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons;
 - (ii) approach the Supreme Court or the High Court concerned for such directions, orders or writs as that Court may deem necessary;
 - (iii) recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary.













Among the missing cases, approximately 80% were female children and rest is male. In case of girls, most of the cases were lodged after they fled away with their fiance to get married. Their family members lodged missing diaries. In some cases, they got married, sometimes they were caught before marriage. In few cases they remained untraced. They are also trafficked for the purpose of domestic labour, commercial sexual exploitation.




Most of the child abuse cases addressed by the Commission included the cases where children were abused physically and mentally by their family members as results of family disputes and by the outsiders also.

It is mention worthy that in 2017-18 the number of reported death cases was 33, whereas in 2018-19 the number of death of children increased to 79. But last year 2019-2020 it went up to 83. Suicide among teenagers, child tortured to death, medical negligence were the main contributing factors for child death.









WhatsApp Helpline

WBCPCR launched its 24x7 WhatsApp Helpline - 9836300300 in 2018. The Hon'ble Minister of State (IC) Dr. Shashi Panja had announced this WAP helpline number in a WBCPCR's programme in Baharampur, Murshidabad. This Helpline number got activated from 10 September, 2018. Since then a number of child rights violation cases of various categories were registered with this helpline number. The cases were addressed by the Commission and actions were taken. Sometimes, complainants also visit the Commission & lodge the complaints personally or mail the complaints to the Commission even after registering the case on helpline. In the period of April, 2019 – March, 2020, out of 48 cases, 45 cases of child marriage were registered through this helpline number. Most of them were prevented by the Commission with the help of the district administration, police and Childline.

Actions Taken

Methodology of intervention: How cases are addressed

1. Visit

The Department of Women & Child Development and Social Welfare, Government of West Bengal has set up West Bengal Commission for Protection of Child Rights in exercise of powers under sub-section (1) read with clauses (a) to (d) of sub-section (2) under section 36 of the Commission for Protection of Child Rights Act, 2005 with the objective of ensuring protection of children against all forms of abuse and violation of child rights. The Commission has also been mandated to examine all factors that inhibit enjoyment of child rights, look into the matters relating to children in need of special care and protection including children in distress. The Commission is responsible to recommend appropriate remedial measures, analyse laws to examine their compliance with the UN Convention on the Rights of the Child, 1989 (UNCRC) and recommend remedial measures.

The Commission is also meant to serve as a forum which children can access easily in order to seek redress for the violation of their rights.

The mandate also includes inspecting and monitoring custodial institutions for children to examine the situation and facilities as per Juvenile Justice (Care and Protection of Children) Act, 2015. Through visit and in-depth analysis, the Chairperson, members and consultants provide inputs and suggestions to improve the services, ensure child friendly atmosphere within the institution.

Visits are conducted in two ways: a) Regular routine visits to assess the compliance b) Based on a complaint against the custodial institutions regarding any incidents of torture, unavailability of services meant for children, bad behaviour of caregivers etc.

The Commission gets the complaint from the district administration authority, electronic and print media report and individual citizens, even sometimes by any anonymous person.

After the visit, reports are prepared and sent to the concerned authority for taking action. Follow up visits are also conducted wherever it is required.

In the last year, numerous public and private schools have been visited to examine and review the safeguards for rights and recommend measures for their effective implementation. The Commission has taken proactive steps based on the complaint against the Head of the institution, a particular teacher/a group of teachers, School Management Committee by visiting the schools, meeting with the authorities, sending letters to concerned authorities. The Commission has taken suo motu cognizance in a large number of cases before police has taken any action.

A few Madrasahs in several districts of West Bengal were also visited where interaction and discussion took place on child rights and child protection.

As per the POCSO Act, WBCPCR is assigned to monitor the implementation of the Act. So, the Commission takes suo motu cognizance and also takes action based on the complaint lodged by

individual, Non-Government Organisations, reports published in electronic and print media and other Commissions.


Based on the nature and gravity of the complaint, the Chairperson, members, consultants visit child friendly corners of police stations, attend court proceedings, meet the survivors, visit hospitals and health centres, ICDS centres, Correctional Homes to do a comprehensive assessment.

2. Hearing

In exercise of the powers under Section 14 of CPCR Act, 2005, the Commission has the power to summon and enforce the attendance of any person for hearing and examine him/her on oath. Such hearing is necessary for the purpose of inquiry, depending on the situation and circumstances of the case, which culminates to recommendation.

3. Seeking reports, Summoning, Recommendations

The Commission addresses all the complaints received / Suo motu cognizance taken by the Commission at the point of reporting. The Commission has developed a system of registration of complaints, issuing of letters seeking reports, following up with reminders when there is no response from the concerned authorities/ institutions. Depending upon the gravity of the issue it constitutes teams to enquire into the violation of rights and recommends action. When there is no action taken report from the concerned authority/ institution despite reminders given, the accused / concerned persons are summoned.

4. Actions taken: During April, 2019 - March, 2020

Recommendations passed by the Commission: 19

Matters disposed off after taking necessary actions: 40

Case Studies

Case Study I

The case initiated before the Commission when the mother of a student lodged a complaint in WBCPCR. It was alleged that the student of Class II was mentally harassed by the Bengali teacher in the school by calling him beast several times. Although it was an allegation which amounts to mental cruelty towards the child, which is prohibited under RTE Act. It was also alleged that he was not paid any attention by the teacher and the Principal of the said school, finally expelled the said child without any reasonable ground. While perusing the complaint WBCPCR visited the said school for the purpose of enquiry and had a discussion with the Principal of the said school. WBCPCR requested the Principal to allow the child to attend classes but she declined to do that. The matter was reported to Hon'ble Chairperson and she was pleased to call a hearing before the Commission. Both the parties were served hearing notices to appear in person. On the day of hearing before the Commission the school authority did not turn up willfully rather they were represented by their lawyers. WBCPCR decided to send another hearing notice to the School authority wherein the school moved to the Hon'ble High Court in Calcutta for stay of hearing before the Commission. The Hon'ble High Court entertained the matter and passed a judgement in favour of the Commission and the child. It was directed by the Hon'ble High Court to allow the child to attend classes and directed the Commission to continue the hearing and make recommendations in the best interest of the child. The Commission called another hearing as per the direction of Hon'ble High Court where both the parties to the suit were present and made their submissions. After hearing both the parties the Commission passed recommendations keeping in mind the future of the child, directing the school authority to undergo workshop under RTE Act and Juvenile Justice Act, to show compassion towards the child, to give an apology towards the parents for harassing the child and to refund the one year school fees as a means of compensation since the child was traumatised and as a result the parents decided to not send the child anymore to the School. It is pertinent to mention that the school authority at first deliberately and willfully disobeyed the recommendations and was not ready to pay compensation to the child which was expressly given by the Principal by a letter to the Commission. Thereafter the Commission decided to serve a Legal notice for compliance of the recommendation in strict words and finally the school was bound to comply with WBCPCR's recommendations by giving compensation to the child.

Case Study 2

West Bengal Commission for Protection of Child Rights took cognizance of the complaint received from the guardians of Class-X of a school, Howrah regarding mental and physical harassment of students pursuant to a missing ice-cream on Children's Day Celebration on 14th of November 2019. As per the complaint the girls and boys of Class-X were punished for a minor issue after an ice-cream went missing. The Principal ordered a full body search of all the boys and girls of Class-X and the Principal also refused to allow the children to sit for their preparatory examination which were going on for about a month in the school, which was a gross violation of child rights. Based on the complaint, one of the

Members along with two consultants of the Commission visited the school but the meeting went in vain.

After the visit, this Commission decided to call for a Hearing. Three of the girls elaborated on the incident that happened with them. The school authority showed a CCTV footage of the examination hall, where the date and time of the footage had been distorted. The Principal and the other representatives of the school claimed that the CCTVs have been vandalized by the parents only. But after a long discussion and negotiation, the Principal continuously refused to allow children to sit for their Board Examination.

Therefore, the Parents filed a writ petition before the Hon'ble Calcutta High Court for necessary reliefs. After the Hearing at the Commission, a recommendation had been sent to the Hon'ble High Court. Finally, the Commission won the case and the Hon'ble Court took the decision for the best interest of the children and directed the school to allow the students to appear for ICSE 2020.

Case Study 3

It was a late evening of February, 2020. A sudden phone call came to a Consultant of WBCPCR from a journalist that one of his relative's 13-year old daughter was threatening her parents to commit suicide if they did not marry her off with a 21-year old boy. He wanted to know whether the Commission could intervene in this matter. The consultant promptly suggested the Journalist to send the girl with her parents to the Commission's office next day & informed the Chairperson.

Next day the Commission got to know a different story.

The girl had developed an affair with the man and had eloped with him. They got "married" & stayed together for few days then came back home. Then she started pressurizing her parents to accept their "marriage" & kept threatening to commit suicide if they did not comply. The Commission then & there tried to convince her parents to lodge a complaint against the man as it was clearly a POCSO case. At first, they were hesitant. Later they agreed & lodged an FIR against the man. The girl was produced before the Child Welfare Committee of the district. The girl was required to be shifted to safe custody & by order of CWC she was taken to a government run Child Care Institution. The accused man was arrested by the police. The guardians of the girl sent a letter to WBCPCR appreciating its role.

Case Study 4

It was July, 2019. A minor girl child went missing in Kolkata. She was the only child of her parents and her father worked as a mason and mother as a maid. The matter was reported in the concerned police station. A person who knew her father reported the matter to the Commission as she was yet to be traced. The Commission then and there asked the police to send the action taken report & pursued the case in every concerned level. Within 72 hours police informed the Commission that they could locate the girl in a neighbouring state and they suspected a notorious human trafficking gang was involved in kidnapping the girl. The girl was rescued within 7 days and handed over to her parents which much to their relief. But the traffickers escaped.

Chapter 5: Activities and Programmes Undertaken

I. Activities

- Review Meeting: Quarterly review meeting with Police, Chairperson and Members of Child Welfare Committees, DCPOs and DSWOs, Superintendents of Government and NGO run CCIs are conducted on a regular basis to discuss the problems they face while working for children and resolve those as far as possible. Interactions among different stakeholders help remove bottlenecks and render justice to children.
- Collaboration with NGOs: The Commission collaborates with the NGOs for working on child rights and child protection across West Bengal as they have knowledge, expertise and easy access to reach people living in grass root level. The Commission organises sensitization programme on several issues with them, prepares policy documents with the support of the NGOs, and gets support in follow up of cases. The Commission gets huge support from NGOs in organising State Child Protection Day Programme, International Child Rights Day Programme, setting up child friendly corners in Kolkata International Book fair, Poushmela in Santiniken and in Gangasagar Mela.
- Action Research: The Commission undertakes action research projects based on the emerging needs in society and to bring change in knowledge, policy and practice in terms of promoting child rights and ensuring child protection.
- Training session organised for Members, Consultants and other staff: A training session
 on Mental health issues in school children, was conducted by Dr. Rima Mukherji, renowned
 psychiatrist of Kolkata

Public Hearing

Public hearings serve as a platform to garner opinions, grievances or complaints on matters of public interest and attempt a resolution. It is aimed to assess the implementation of laws, rules, regulations, policies or programs aimed at the protection and promotion of child rights. Depending upon the sensitivity of the issue being considered by the Commission, public hearings may be open to all or restricted to only the victims, witnesses, their families and NGOs supporting them.

The Hon'ble Chairperson, WBCPCR met a child victim from a closed down tea-garden and heard her testimony on the condition of children's lives in such hotbeds of injustice and deprivation. This prompted her to unearth the grievances of the poor families of the tea-gardens who are mostly unheard and whose children get mostly affected. To highlight these issues before the administration and civil society, WBCPCR in exercise of its powers conferred under Section 13(1) of CPCR Act, 2005 held a Public hearing with Action Aid, Kolkata in Alipurduar on 11th June, 2019.

Educational Sponsorship

BNI Ideal Kolkata Chapter Meeting took an exemplary initiative of sponsoring one year of free

education of girl children who need it most. WBCPCR with the help of NGOs identified 6 girl children who belonged to the marginalised community and faced child rights violation in their lives. In spite of their marginalisation, conquering all difficulties these children are pursuing their education and would do so in future as well. BNI Ideal Kolkata Chapter handed over the cheques to those Girl Children towards their one year of free education during their BNI Ideal meeting.

Research Work

In the past one year, the Commission took four research works-

- a) "Dipstick assessment on impact of Domestic Violence on Children" Study done by WBCPCR in collaboration with Action Aid India & Jayprakash Institute of Social Change, All Bengal Women's Union (ABWU), South Kolkata Hamari Muskan and School of Women's Studies, Jadavpur University.
- b) A Critical analysis of POCSO cases (based on the cases submitted to WBCPCR) to review its justification, implementation and practicability Study done jointly by WBCPCR and Jabala Action Research Organisation.
- c) A Research work jointly taken up by WBCPCR & Kolkata Sanved on 'Mental Health Gap Assessment of Residents in the CCIs of West Bengal'. This research work was to be completed by the next year.
- d) Proposals were invited by WBCPCR for a study on Child Marriage, its trends towards prohibition & gap analysis between the policies & its intervention in West Bengal.

Among these three research works first two were completed & others are ongoing.

II Child Friendly Fair

Poushmela, Santiniketan

Since 2016, the Commission has been organising a Child Friendly Corner in Poushmela in collaboration with the District Administration of Birbhum. It was for the first time in the state of West Bengal a fair or festival was recognised as a Child Labour Free Fair. This year the Commission in collaboration with the district administration gave Child Labour Free plaques to stalls who practised this in the fair. Sri Ashish Banerjee, the Hon'ble Minister of the Department of Agriculture, West Bengal graced the occasion as the Chief Guest. Children across the districts were involved in many activities like drawing competition, craft making workshops. They performed and enjoyed cultural programmes every evening and became sensitized about their rights. Each child was given a hand band stating his/her name, address and contact numbers so that they could be traced easily if they went missing.

International Kolkata Book Fair

Since 2018, the West Bengal Commission for Protection of Child Rights (WBCPCR) has been organising a Child Friendly Corner at the International Kolkata Bookfair. Children from different corners of West Bengal participated and enjoyed. It created a huge impact among visitors in the book fair as WBCPCR

is the first Commission in India to set up a Child Friendly Corner in book fair.

In 2020, the Commission was also allotted a good space in the International Kolkata Bookfair & the Child Friendly Corner was installed with the focal theme Hansel and Gretel, famous Children's classic fairytale from Germany. Dr Shashi Panja, the Hon'ble Minister of State (IC), DWCD& SW inaugurated the child friendly corner of the Commission in the 44th International Kolkata Book Fair on 29th January, 2020. Renowned film star Sri Chiranjit Chakrabarty and music star Sri Surajit Chatterjee graced the occasion with their presence. Ms Ananya Chakraborti, the Hon'ble Chairperson of WBCPCR along with her members was present in the programme. A large canvas was placed at the child friendly corner where children from various segments drew pictures and cartoons. The first touch was given by the Hon'ble Minister as well as by Sri Chiranjit Chakrabarty who is also a remarkable painter.

Hullor, the children's magazine of the Commission completed its three years of publication. All the copies of Hullor and other publications including IEC material like booklets, posters and research reports on several child rights issues were displayed at the corner.

More than one thousand copies of Hullor, December 2019 issue & Pujasankhya were sold & distributed among children & interested readers. There were many who had collected Hullor last year and this year too they stepped in the corner to get a fresh copy of the magazine.

Leaflets containing informations on child rights and WBCPCR helpline & other important child protection related issues were distributed in the book fair.

Kolkata International Bookfair continued from 29th January to 9th February 2020. During this period, approximately 10, 000 children along with their guardians & adults visited the corner, staged performance, took part in quiz sessions, games and other activities conducted by the Commission.

There were three layers of activities & participation of children.

- 1. Children from Child Care Institutions and disadvantageous communities across Kolkata and nearby districts showcased dance performances, songs, issue-based dramas/skits, self-defence shows.
- 2. The NGOs and Community Based Organisations in and around Kolkata participated and helped the Commission conduct various activities with children which are as follows.
- Quiz on general knowledge and active citizenship
- Several interactive and edutainment games
- Demonstration of Martial Arts
- Art workshop
- 3. Celebrities and noted professionals from different sectors visited the corner & conducted several workshops for the children.
- Pracheta Gupta, writer: Story reading session
- Biswanath Basu, actor: Acting workshop
- Debiprasad Duary, Scientist: Session on sky watching & Solar system
- Satyarup Siddhanta, Mountaineer: Workshop on Mountaineering

- Dr. Arundhati Sarkar, Director, Manochetana Academic & Research Centre : Interacted with children on mental health
- Bithi Chattopadhyay, Poet: Poetry writing workshop
- Sharmistha Sarkar, Artist: Art workshop
- Troy Roy Chowdhury, Quiz Master: Workshop on Bengali word making
- Dohar, music band: Music workshop

Poetry, limericks & drawings created by children in the workshops were published in the WBCPCR's children's magazine, Hullor and a painting created on a large canvas in the workshop by the children of a Child Care Institution has been installed in the CPCR's office as a memento. It gave the children a sense of ownership.

Renowned Radio Jockeys of Kolkata RJ Sekhar and RJ Manali moderated the entire 10 days of activities with their innovative ideas and enthusiasm which made the events interesting for children. There were gifts & prizes for children supported by UNICEF.

Gangasagar Mela

WBCPCR in collaboration with the Department of Women and Child Development & Social Welfare

organised its second Child Friendly Corner from 10 to 15 January, 2020 at the Gangasagar Fair. The Commission felt it important to organise the corner there as there was always a possibility of threat with regard to safety and security of children in the fair. Children get missing from the fair and get trafficked on the pretext of job offers and marriage proposals. It is also observed that children are employed as child labour and beggars. So, two child friendly corners were organised by the Commission — one in Kachuberia and another in the Gangasagar Mela ground. The IEC materials in Hindi, Bengali and English were



distributed among all pilgrims. Leaflets containing child helpline numbers like Child Line, WhatsApp Helpline number of WBCPCR were distributed throughout the mela ground. Audio and video spots were used to campaign against child labour, child marriage, missing and trafficking.

Little Magazine Fair

WBCPCR participated in the Little Magazine Fair 2020 that was held from 11 January to 15 January, 2020 at Rabindra Okakura Bhawan, Bidhannagar with its set of publications including its children's magazine Hullor.

Bhangar Bookfair

WBCPCR also participated in the Bhangar Bookfair with its publications & awareness building leaflets. Hullor, the Children's Magtazine of WBCPCR received a huge response from readers & children.

III Awards of WBCPCR

- Birangana and Birpurush Puraskar: Bravery Award for children was introduced by the Commission in 2016. Girls and boys across the state who play proactive roles in prevention of child marriage and child abuse, facilitate education & work for protecting child rights and inspire their communities & country are felicitated and awarded with plaques and certificates. Children who rescue lives from accident or any disaster and serve the community are also felicitated. In 2019, 25 boys and girls received such Bravery awards from the Commission. This year three male children of 2 to 3 years of age from Bankura district received the awards while their mothers held them on their lap. They saved the lives of thousands of passengers by making a speeding passenger train stop before it could cross over a broken railway track. They could see a gap in the train line while playing & promptly went to a house, took a red torn cloth & flagged the train down standing on the side of the line. The train driver could see and understand the signal and stopped the train & all passengers were saved from a fatal accident. There was also a case where a girl was sexually assaulted and offenders tried to burn her. Now she is a meritorious student fighting out the battle of life.
- Shishushree Award: This Media Award based on Child Rights reporting was introduced in the year 2017 to sensitize media and society on protection of child rights and the rights of minors. WBCPCR aspires to recognize and honour those journalists of Bengal from both print and electronic media (in Bengali & English) who have endeavoured to uphold child sensitive issues in a responsible manner and thereby sensitize readers and viewers. In 2019, 8 journalists received the Shishushree Award. 4 journalists received certificates of Special Mention.
- Police Bravery Award: In 2018, the Commission announced the Police Bravery Award for Child Friendly Police Officers. They are awarded for their performances towards protecting rights of Children in Need of Care & Protection. The criteria of selection is whether the police is aware of all provisions of JJ Act and POCSO Act, whether he/she has shown courage in preventing crimes against children and done something to build awareness on Child Rights as well as child protection, whether he/she has played a proactive role and shown responsibility towards cases involving children. In 2019, 3 Police Officers received this award.
- Best Superintendent of CCI and the Best CCI Award: The Commission introduced the award for the Best Superintendent of a CCI and the Best CCI in West Bengal. The Commission formed a Selection Committee and selected such CCIs and Superintendent who showed exemplary initiative to keep children in a safe, secured and child friendly environment with minimum resources. It was also observed whether the West Bengal Juvenile Justice (Care & Protection of Children) Rules, 2017 were followed properly. In 2019, Uttarpara Shishu Abash, Hooghly and Edith Wilkins Street Children Trust Fund, Darjeeling received this award.

IV. Observation of Days

• The State Child Protection Day: In 2019 The State Child Protection Day was observed by WBCPCR in North Bengal. On 9th June, 2019 in partnership with the Department of Women & Child Development & Social Welfare, UNICEF and other civil society organizations WBCPCR organised the programme at Dinabandhu Mancha, Siliguri so that more children from North Bengal could participate in the celebration.

Two important personalities were felicitated for their invaluable contribution to society-Janab Karimul Haque & Sri Sovon Mukhopadhyay. Padma Shri recipient Karimul Haque is locally known as Bike-Ambulance-dada for his work of supporting the villagers in and around Dhalabari by transporting sick people to hospitals on his bike. Sri Sobhan Mukhopadhyay, a Masters' student of Kolkata University is the first person in Kolkata who started distributing sanitary napkins at pay and use toilets in Kolkata in 2017. A booklet on stopping child marriage "No marriage now" was released in the programme. Children from different districts of North Bengal performed and participated in the programme.

- Child Rights Week: The Commission celebrated Child Rights Week from 14 19 November in 2019 all over West Bengal. More than 15,000 Children from all districts participated in the week long programmes in their respective districts. On 14th November the Child Rights Week began in Kolkata with a colourful tram rally organised by WBCPCR, where five trams with children from CCIs and communities converged in Esplanade tram depot from five different points of the city. Children along with a number of celebrities performed there. On 15th November approximately 100 children visited the Victoria Memorial Hall, Kolkata to witness the forgotten history of Bengal and India. Responding to the appeal by the Commission, the Victoria Memorial authority provided this wonderful opportunity to underprivileged children free of cost.
- International Child Rights Day: This week long programme came to a conclusion with the celebration of the International Child Rights Day at Mohorkunja, Kolkata on 20th November, 2019. More than 1000 children from various parts of West Bengal participated in this carnival. 2019 was also the 30th year of CRC (Convention on the Rights of the Child).

Dr. Shashi Panja, Hon'ble MOS (IC), DWCD & SW of WB inaugurated the carnival. Sri Debashish Kumar, Mayor in Council, KMC was present as Special Guest. Sri Vinod Kumar, IAS, Secretary, DWCD & SW of WB & Md. Mohiuddin, Chief of Office, UNICEF WB graced the occasion with their presence. Smt. Ananya Chakraborti, the Hon'ble Chairperson, WBCPCR presided over the programme.

A survey report on "Exploratory Research: Dip-stick Assessment on Impact of Domestic violence on Children" conducted by the Commission with support of UNICEF was released at the programme.

A booklet on Cyber Safety (in English & Bengali) for children published by the Commission was released as well.

Four categories of awards were delivered. Bravery awards (Birangana & Birpurush) were given to 25 children of West Bengal for upholding child rights, Shishushree Awards were delivered to journalists for best reporting on Child Rights. Awards were also presented to Child Friendly police and Child friendly CCIs. There was an exhibition of late Trina Lahiri's works. There were several performances by children, shows on dance movement therapy, painting workshop along with other activities in the carnival.

• National Girl Child Day: The Commission celebrated the National Girl Child Day on 24th January, 2020 with the residents of Sneha Child Care Home for girls, Sanlaap, Narendrapur, South 24 paraganas. A colourful cultural programme with various sports activities along with a small get together was organised on that day.

Chapter 6: Significant Achievement

Recomendation for introduction of mental health page in school diary

The West Bengal Commission for Protection of Child Rights organised a very important consultation on RTE Act with SSM, Members of the Expert Committee of School Education, teachers and students from private and Government schools, Guardian Forum, RTE Forum and member of ICSE Board on 7th February, 2020 at the Conference Hall, WBCPCR. Various important RTE related issues were discussed. The Commission has come out with important advisories for teachers and guardians along with few recommendations on RTE Act which was sent to the concerned departments.

WBCPCR passed the recommendation for introduction of mental health status page in the school diary. This was sent to the concerned departments and all the existing school boards in the state.

Re-looking of POCSO Act, 2012

WBCPCR organised an Inter-State Consultation on the POCSO Act, 2012 in collaboration with Directorate of Child Rights and Trafficking, West Bengal, to put together a studied proposal for required changes of the POCSO Act on 25th February, 2020 at Satyajit Ray Auditorium.

The Chairpersons and members of eleven State Child Rights Commissions, NCPCR along with representatives of police enforcement, Judiciary, medical field, Child Protection units, JJB, SLSA, NGO/s and other pertinent stakeholders participated in the Consultation & came out with a bouquet of recommendations on much required amendments of POCSO Act, 2012.

Prevention of Child Marriage

It was 15 August 2019, the West Bengal Commission for Protection of Child Rights' WhatsApp Helpline number received a complaint regarding a child marriage to be solemnized on that evening at South 24 Parganas. The information was immediately communicated to the concerned district officials (District Social Welfare Officer as well the District Child Protection Officer). The district administration further communicated with the local Police station and a rescue team including police officials and officials from the district administration visited the residence of the minor.

When the officials reached the site the minor was not present. WBCPCR was getting the updates from informants that the minor girl had been taken to her uncle's place to avoid the police action. This message was communicated to the concerned officials and the whole team went to the 2nd location. But the minor was still not found as again she had been transferred to a 3rd location. Continuous communication process and follow up with the rescue team were on and finally the minor was recovered from the 3rd location late evening before the marriage ceremony. The father and uncle were arrested, along with the priest and the minor was placed at the CCI.

Chapter 8: Role of the Commission in the Time of CORONA

In January, 2020 most of the World was unaware of CORONA. In the second half of March, the virus spread to almost every country causing deaths of more than several thousand people all over the world. It crashed economies and broked health-care systems, filled hospitals and emptied public spaces. It separated people from their workplaces and friends leading to a total disruption of modern society on a scale that most living people had never witnessed before.

Government of India declared total lockdown of 21 days. Government of West Bengal under the leadership of the Hon'ble Chief Minister Smt. Mamata Banerjee fought out this CORONA crisis bravely.

The entire team WBCPCR worked actively from home & addressed all complaints received by the Commission including suo motu cases & took steps amid the lockdown.

- 1. The cases addressed amid the lockdown (from 23 March- 31st March).
- 2. **Helpline:** WBCPCR launched a helpline for children under stress amid the lockdown and circulated it to all District Officials, police stations in Kolkata & West Bengal. The objective was if children felt stressed or faced mental health problems, they and their guardians could consult doctors & professionals whose numbers were given in the Helpline chart issued by the Commission. Responding to the request of the Commission a group of doctors, physicians & professionals extended their support for children completely free of cost.
- 3. Activity Chart for children: WBCPCR also prepared a routine to keep children happy amid the lockdown. These were circulated through WBCPCR's website & social media & news papers.
- 4. **Diet chart for children:** WBCPCR shared a balanced diet plan to keep children healthy amid the lockdown. It was prepared by Smt. Shampa Chakrabarty, Consultant Dietician & circulated through the Commission's website and social media.

Chapter 9: Publications of WBCPCR

HULLOR

West Bengal Commission for Protection of Child Rights publishes a children's magazine- Hullor. It is a quarterly magazine of and for the children.

It is a prominent children's magazine in the country, where minors from a wide cross-section of society, including CCL (Children in Conflict with Law) and CNCP (Children in Need of Care and Protection) children can voice their opinions, depict their dreams and illustrate their aspirations side by side with celebrities like Sankha Ghosh, Sourav Ganguly, Ruskin Bond or Bachendri Paul.

It obtained due registration from Registrar of Newspapers for India (RNI) as WBCPCR CHILDREN



MAGAZINE (Reg. No. WBBEN/ 2018/76942).

Since its inaugural issue, Hullor received huge appreciation from all quarters specially from the children of CCIs and school children. They rarely get any scope to read a Ruskin Bond story or a Sourav Ganguly's interview or to get in touch with Chiranjit's paintings which they get here.

Children get the flavor of wildlife of Masaimara, Kenya or Bandhabgarh, Madhyapradesh through the lens of eminent actor and wildlife photographer Sabyasachi Chakrabarty. At the same time, Bachedri Pal, the first Indian woman who reached the summit of Mount Everest tells them about the golden rules of how to scale mountains, as well as unprecedented obstacles in life.

Simultaneously, there are several sections like the Cover Story or Counselling which deal with child rights issues like Right to Education, Trafficking, Kanyashree, Right to Play, Child Marriage. Hullor introduced a new comic strip "Dhishum" where children, dare and confront various obstalces to protect child rights. They represent all brave children of Bengal.

In brief, Hullor inspires children to learn how to think and also empowers them with better awareness regarding rights of children ensured under the acts and provisions implemented by CPCR.

Other Publications

- i. A booklet on Cyber safety was formulated & published by WBCPCR on the International Child Rights Day Carnival 20 November, 2019 at Mohor Kunja.
- ii. WBCPCR's booklet on Child Marriage- "Ekhoni biye noy" was released by the Hon'ble Minister of West Bengal Sri Gautam Dev on 9th June, 2019 at Siliguri at the State Child Protection Day Programme.
- iii. WBCPCR's calendar of 2020 was released by the Hon'ble MOS (IC), DWCD & SW Dr. Shashi Panja at the Conference Room, WBCPCR. The 2020 Calendar was based on Sukumar Ray's Abol Tabol. It gained tremendous popularity among children as well as a huge cross section of the Bengali society.

Chapter 10: Recommendations by WBCPCR (2019-2020)

1. POCSO RELATED ISSUES:

The Protection of Children from Sexual Offences (POCSO) Act, 2012 was passed to provide a robust legal framework for the protection of children from offences of sexual assault, sexual harassment and pornography, while safeguarding the interest of child at every stage of the judicial process. With its implementation over the years, it was realized that not all issues could be addressed by the same act and need for modifications, additions, alterations and amendments to POCSO Act, 2012 was felt. Since it is a central act, amendments are to be made by the parliament, but the recommendations need to be provided to the legislature. Therefore, WBCPCR proposes the needed recommendations as follows.

- i. The 3 stages of childhood, viz, early childhood, mid-childhood and adolescence need different kinds of handling. There should be different categories or provisions for each category under the POCSO Act.
- a. India is a country of diverse cultures, practices and customs. The POCSO Act needs to recognise these diversities and adapt accordingly.
- ii. A professional committee of support persons is a must to handle the social, legal and other kinds of trauma for the victim and family and these need to be factored into the POCSO Act.
- iii. Legal action should not be imposed on everybody at the time of reporting. This might aggravate the trauma of the child. In the best interest of the child, trauma management and healing of victims should take precedence over legal procedures under the POCSO Act. The child and the family must be made ready to face the legal process after adequate counselling.
- iv. Whether reporting is mandatory or not, investigation must be started.
- v. POCSO needs to look into situations not only through the legal lens but also factor in the psychological and sociological context.
- vi. There is a need to recognise the existence of adolescent sexuality and decriminalise consensual sexual acts. It is naive in this day and age to assume that children are asexual beings till the age of 18 and suddenly become ready for marriage, sex and parenthood immediately on turning 18. POCSO needs to come out of this denial and recognise the difference between a sexual act and a sexual offence/exploitation.

- vii. While the POCSO Act may continue to cover all individuals till the age of 18, the age of consent needs to be lowered to 16.
- viii. The Judiciary needs to be given the discerning authority under POCSO to differentiate between cases of romantic relationships leading to elopement and genuine POCSO cases.
- ix. The medical examination of the victim is critical. There is a dearth of female doctors in hospitals for this purpose. There needs to be a window that allows male doctors to examine the victim in case of a male victim, and examine a female victim in the presence of a female nurse/female family member, in cases where a female doctor is not available.
- x. Apart from the physical evidence, there is a need to examine the emotional and psychological damage of the victim. The POCSO Act needs to factor in NGOs, Social workers, counsellors to examine the victim.
- xi. Issuance of notice to the victim should be mandatory in bail/anticipatory bail cases.
- xii. Effective coordination of the stakeholders is needed in post cognizance stage.
- xiii. There must be more female lawyers in handling POCSO cases Both as Special Public Prosecutor and representing the child.
- xiv. Victim protection scheme needs to be factored into the POCSO Act. Security and shelter must be provided to the victims and their kin wherever required. Extra security must be provided when accused person gets bail.
- xv. Provisions for video conferencing.
- xvi. Need for more Forensic Laboratories for submission of on-time FSL Reports to expedite filing of Charge sheet .
- xvii. Compensation to be paid from the Perpetrator is Additional to Scheme—which needs to be informed to the victim child
- xviii. Need to sensitize all stakeholders regarding compensation schemes.
- xix. There is a need to have dedicated child friendly police.
- xx. There is need for one dedicated support person from the point of taking cognizance till the disposal of the case. The cost of that must be borne by DLSAs.
- xxi. There needs to be specific SOP / guidelines for medical practitioners for mandatory reporting of POCSO cases.
- xxii. The medical kits should go directly from the hospital to FSL to prevent any damage to evidence.

2. RTE RELATED ISSUES

Age Limit of Compulsory Education may be extended: The Commission has been receiving several complaints from the pre-primary schools where the issues regarding admission, fees, school safety are raised. But the Commission cannot intervene in the cases, as RTE starts from the age of six. So, it is recommended that the age of RTE may be lowered to two and a half years of age.

3. MID DAY MEAL

The Commission has noticed that there are several siblings who study in the same Government school and they come from an under-privileged background. One of them may study in class 7 and another may be in class 9. Therefore, as per the rule, one gets mid-day meal and other does not. This is not desirable. So, the Commission recommends that the RTE may be extended till class X, along with the provision of mid-day meal.

4. FEE STRUCTURE OF PRIVATE SCHOOLS

Charging of exorbitant fees by private schools is a major cause of concern. In the past few years, the Commission has had to deal with a considerable number of such cases. So, the Commission has come up with following recommendations.

- i. There is a need to formulate guidelines in the State Rules to curb the tendency of arbitrary increase in admission fees by private schools as it adversely affects the spirit of RTE. There may be a ceiling in admission and session fee hike.
- ii. Re-admission fee in every class is not acceptable and this issue needs to be addressed by the School Education Department.

5. MENTAL HEALTH RELATED ISSUES

It has been observed by the Commission that due to increased pressure in schools, parental pressure and a negative perception of life, young children develop stress, depression and anxiety. Resultantly they commit suicide. Most of the times, the information of their mental health concern is not shared with the school authorities as parents often go into denial mode when it comes to their children's mental health. Thus, the Commission is recommending the following.

- i. Teachers need better orientation: The teachers of every school need to be properly oriented and sensitized to nurture and safeguard the mental health of their students.
- ii. An Advisory Guideline for Parents/Guardians should be provided: Parental conditioning is also necessary to maintain a healthy environment for a child. The Guideline may cover the dos and don'ts for the parents/guardians, for their child's welfare. The Guideline should be included in the school diaries and be circulated to all parents/guardians during the admission procedure.

6. Introduction of Edutainment Based Workshop In Child Care Institutions

Child Friendly Corner of WBCPCR in Kolkata International Bookfair had a huge impact among children visiting the fair as well as the children of Child Care Institutions who participated in various edutainment workshops organized by the Commission at the corner. They wrote poems, made stories on the spot. It seemed they enjoyed storytelling and poetry making sessions & acting workshops thoroughly. Thus, the Commission recommends that this kind of workshop needs to be introduced in Child Care Institutions also. Celebrities & noted professionals of different fields may be engaged in such projects. It will help them enhance their motivation in life.

শিশুদের সমস্যা মেটাবে শিশু অধিকার সুরক্ষা কমিশন

কালীঘাটের যৌনপল্লীর মা ও শিশুদের জন্য খাবারের ব্যবস্থা করল রাজ্য। পাশাপাশি ঘরবন্দি অবস্থায় রাজ্যের কোনও শিশুর মানসিক সমস্যা হলে কাউন্সেলিংয়ের ব্যবস্থাও করা হল। এর জন্য একটি ওয়েবসাইটও খোলা হয়েছে। একটি স্বেচ্ছাসেবী সংগঠনের সহযোগিতায় কমিশন শনিবার থেকে সেখানকার সব শিশুর দু'বেলা ভাত-ডালের ব্যবস্থা করেছে। কমিশনের চেয়ারপার্সন অনন্যা চক্রবর্তী বলেন, 'শিশুরা কোনওরকম সমস্যায় পড়লে আমরা সবসময় সাহায্য করতে প্রস্তুত। অফিস বন্ধ রয়েছে। কিন্তু ফোন, এসএমএস, হোয়াটসঅ্যাপ, ই-মেলের মাধ্যমে সবসময় যোগাযোগ করা সম্ভব। কালীঘাটের যৌনপল্লীর মায়েরা কালীঘাট থানায় তাঁদের সমস্যার কথা জানিয়েছিলেন। থানা থেকে আমাদের কাছে খবর আসে। আমরা সঙ্গে সঙ্গে ব্যবস্থা নিয়েছি।

আমাদের ডাকে সাড়া দিয়ে অ্যাসেম্বলি অফ গড় চার্চ মা ও শিশুদের খাবারের ব্যবস্থা করছে।

শুধু কালীঘাটের যৌনপল্লী নয়, রাজ্যের যে কোনও প্রান্তের শিশু, এমনকী পথশিশুদেরও সমস্যা হলে কমিশন ব্যবস্থা নেবে। করোনা মোকাবিলায় গোটা দেশে লকডাউন চলছে। একই পরিস্থিতি এ রাজ্যেও। স্কল বন্ধ। খেলার মাঠে যাওয়া বন্ধ। এমনকী পাশের বাড়ির শিশুর সঙ্গে খেলাও বন্ধ। এই পরিস্থিতিতে কোনও শিশু যদি মানসিকভাবে অসম্ভ হয়ে পড়ে তাহলে তাদের কাউন্সেলিংয়ের ব্যবস্থা করেছে শিশু অধিকার সুরক্ষা কমিশন। এই সংস্থার ওয়েবসাইটে মনোবিদ এবং মনোরোগ বিশেষজ্ঞ, শিশু চিকিৎসকের নাম ফোন নম্বর ও কখন যোগাযোগ করা যাবে তার বিস্তারিত তথ্য দেওয়া আছে। কমিশনের চেয়ারপার্সন বলেন, 'দীর্ঘদিন ঘরবন্দি থাকলে শিশুদের সমস্যা হতে পারে। তাই আমাদের এই প্রয়াস।

ঝড়ে যেন শিশু না হারায়, জেলা প্রশাসনকে সতর্ক করল শিশু কমিশন

নিজম্ব প্রতিনিধি, কলকাতা: ঘর্ণিঝড ফণী নিয়ে সব মহল থেকেই নানা সতর্কতামূলক ব্যবস্থা গ্রহণের সুপারিশ করা হচ্ছে। বিদ্যুৎ সংস্থা থেকে শিশু কমিশন—সবারই নানা প্রস্তাব রয়েছে। যেমন রাজ্যের যে সব জেলায় ফণী আছড়ে পড়বে, সেখানে শিশু হারিয়ে যাওয়ার মতো ঘটনা যাতে না ঘটে, তার জন্য সজাগ থাকতে হবে জেলা প্রশাসনকে। এই মর্মে শুক্রবার জেলাশাসকদের চিঠি পাঠিয়েছে কমিশন। এর পাশাপাশি কমিশন এও বলেছে যে, ঝড়ে শিশু হারিয়ে গেলে বা তারপর পাচারের মতো ঘটনা যাতে না ঘটে, তার দিকে লক্ষ্য রাখতে হবে। এর আগে আইলার সময় এমন পরিস্থিতি তৈরি হয়েছিল। তার পুনরাবৃত্তি যাতে না হয়, তার জন্য আগে থেকেই সতর্ক করে দিল শিশু

ফণীর মোকাবিলায় তৈরি সিইএসসিও। তারা এক প্রেস বিবৃতিতে বলেছে, বিদ্যুৎ সংস্থার বিপর্যয় মোকাবিলা দলকে তৈরি রাখা হয়েছে। কলকাতা পুলিসের কন্ট্রোল রুম, কলকাতা পুরসভার কন্ট্রোল রুমে সিইএসসি'র প্রতিনিধিরা থাকবেন। বিদ্যাৎ সরবরাহের উপর কড়া নজর রাখা হচ্ছে। প্রবল ঝড়ের সময়ে নিরাপন্তার খাতিরে বিদ্যুৎ সংযোগ সাময়িকভাবে বিচ্ছিন্ন করা হতে পারে বলেও তাদের তরফে জানানো হয়েছে।

School writes to parents

Regent Park: A city school, where a student was found dead last week allegedly with self-inflicted wounds, has reached out to parents to discuss with them "...issues concerning your child's mental and physical well-being".

A letter addressed to the parents says that the school vice-principal "is always present in the school to talk to you...".

Though such a notice is construed as common practice, the letter stands out considering allegations that several Calcutta schools do not communicate with parents when it comes to dealing with a student's mental and physical well-being.

After the Class X student was found dead on June 21, several guardians of the GD Birla Centre for Education had alleged that the school had always declined to interact with the guardians' forum despite being approached repeatedly.

A parent of a Class IX student said this was the first such notice from the school.

"I don't recall receiving such a notice earlier. I guess last week's incident must have prompted the school to send the notice," the mother of the Class IX student said.

The letter was circulated among the students of the senior section from classes VI-X on June 25.

The letter states that parents may meet the vice-principal on any working day between 1.30pm and 3pm or on Saturdays between 10am and

1pm with prior appointment.

The fact that mental health of students is posing a challenge became evident when more than 100 principals from schools across the city had attended the session on the issue last Saturday.

At the event, several principals approached psychologist Parveen Shaikh, who had stressed the need to develop a closer interaction among parents and schools on mental health.

Farishta Dastur Mukherji, a counsellor of Calcutta International School, said the letter recognised the fact that issues such as mental health could not be handled in isolation.

The West Bengal Commission for Protection of Child Rights on Monday had written a letter to the GD Birla Centre for Education in which, among other things, they had advised interaction between guardians and the authorities on issues such as mental health and safety.

The chairperson of the child rights watchdog, Ananya Chatterjee Chakraborti, said: "The school seems to be opening up to the fact that they need to start communicating with the parents on the issue of mental health. I sincerely hope the move bears fruit."

Repeated calls to principal Sharmila Nath went unanswered. She also did not reply to text messages.

Sanjay Bhattacharya, the spokesperson for the guardians' forum, said they would soon write a letter to the school authorities to convene a formal meeting.

Live in the "now", be positive and stay connected with one another, is the panel's advice. The commission has suggested a list of activities on its website and social media.


